- 3. The purpose of the visit for inspection of Motor cycle is to facilitate bidders to check physical condition before submitting their bid.

- 4.4 Bids opening will be held on 08-11-2024 at 3:00 P.M in the presence of NRL Bid opening committee and bidders or their representative who may wish to attend the bid opening. Successful bidders will be informed accordingly through letter or through email.
 - 5. As per the BOQ, rate/price offered is required to be quoted as net price of each vehicle, exclusive of taxes.
 - 6. GST, Income Tax, SED & other Government Taxes if applicable at the time of handing over the vehicle, shall be payable extra in addition to the quoted rates.
